The O and O licensee is part of the networks cor-porate family; therefore any forfeiture penalty from an obscene, in-decent, or profane broadcast by an O and O would run to the corporate parent. In light of this relationship, it is not unreasonable to expect that O and Os could receive special or favorable treatment as com-pared to the non-O and O station licensees in receiving advance copies of programming or advance notice of controversial content. Given their proximity within the same corporate structure, it is reason-able to attribute knowledge about programming from the network to an O and O.
